What is the overall <u>deductible</u> ?	<u>In-Network</u> \$0 person / \$0 family, Out-of-Network \$200 person / \$500 family.	Generally, you must pay all of the costs from <u>providers</u> up to the <u>deductible</u> amount before this <u>plan</u> begins to pay. If you have other family members on the <u>plan</u> , each family member must meet their own individual <u>deductible</u> until the total amount of <u>deductible</u> expenses paid by all family members meets the overall family <u>deductible</u> .
Are there services covered before you meet your <u>deductible?</u>	Yes. <u>In-Network preventive care</u> , emergency room, and services that require a <u>copay</u> .
