If you have other family members on the plan, each family member must meet their own individual <u>deductible</u> until the total amount of <u>deductible</u> expenses paid by all family members meets the overall family <u>deductible</u> .
Are there services covered before you meet your deductible?	Yes. Emergency care; Tier 1 & in- <u>network</u> office visits, <u>prescription drugs</u> & <u>preventive care</u> ; plus tier 1 inpatient & outpatient hospital services are covered before you meet your <u>deductible</u> . Does this plan provide Minimum Essential Coverage? Yes.
